THIS CAUSE having come to be heard on this the 14th day of April, 2016 on for Trial. The Court abated the Trial and is ordering Intensive Reunification Therapy for Minor Child and Father, it is hereupon,

ORDERED AND ADJUDGED

1. The parties shall engage in intensive reunification therapy with Linda Gottlieb, located in Dutchess County, New York.
2. The child must be accompanied by the Mother on June 26, 2016 to Dutchess County, New York. Father's parents must meet the child at the airport on June 26, 2016.
3. Father will pay for the child's airline ticket. Mother will pay for her own airline ticket.
4. The child must accompany the Father on vacation in Dutchess County, New York for at least one week beginning Monday, June 27, 2016.
5. The counseling shall take place between June 27, 2016 and July 1, 2016.
6. A temporary transfer of physical custody of the minor child is hereby made beginning June 26, 2016.

7. There shall be a sequestration period between the child and the Mother. This includes telephone and electronic communications as well as physical contact. This time period may be shortened or lengthened as therapy continues.

8. Mother shall accept parent counseling services with Linda Gottlieb telephonically.

9. Mother is to provide the child with a letter stating the importance of having her in her life and in what specific ways she supports the reunification.

10. There shall be an indefinite extension of the no contact requirement should Mother fail to support Father's relationship with the child.

11. The parties are to share the expenses for Linda Gottlieb in the following manner:

a) The Father shall pay \$8,000.00 towards the fees of Linda Gottlieb.


12. Temporary physical custody of the child shall be transferred to the Father beginning June 26, 2016.

13. The child shall remain with the Father until the beginning of school, August 14, 2016 unless it is determined that the child needs to extend her stay with the Father.

14. Ms. Gottlieb shall remain in contact with Dr. [REDACTED] the child's psychologist, and the Guardian ad Litem, [REDACTED]

15. Each parent shall have in place their own individual therapists.
